FUND OBJECTIVE

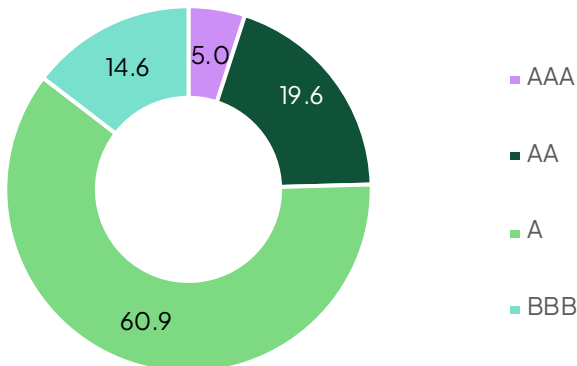
