FUND OBJECTIVE

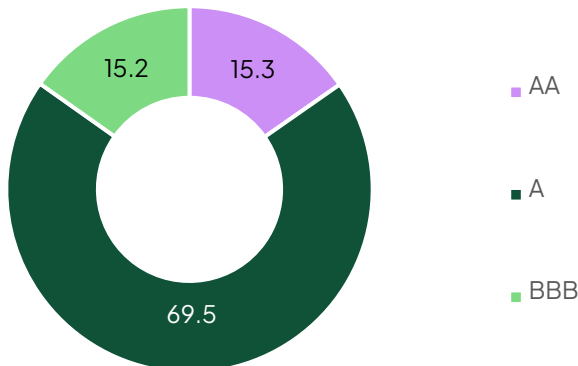
